**WHEREAS**, Section 7503 of the Pennsylvania Emergency Management Services Code, 35 Pa. C.D. Section 7101 et seq. mandates that Silver Spring Township prepare, maintain and keep current an Emergency Operations Plan for the prevention and minimization of injury and damage by a major emergency and disaster within Silver Spring Township; and

**WHEREAS**, in response to the mandate state above, Silver Spring Township has prepared an Emergency Operations Plan to provide prompt and effective emergency response procedures to be followed in the event of a major emergency or disaster; and

**WHEREAS**, Silver Spring Township has also prepared an Emergency Operations Plan in order to reduce the potential effects of a major emergency or disaster and to protect the health, safety, and welfare of the residents of this Silver Spring Township;

**NOW, THEREFORE**, we, the undersigned Supervisors of Silver Spring Township do hereby approve, adopt, and place into immediate effect the Emergency Operations Plan of Silver Spring Township. This Plan shall be reviewed every two years to make certain that it conforms to the requirements of the Cumberland County Emergency Operations Guideline.


