RESOLUTION 2022-03

A RESOLUTION OF THE BOARD OF SUPERVISORS OF SILVER SPRING TOWNSHIP, COUNTY OF CUMBERLAND, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE EXECUTION AND SIGNATURE AUTHORITY, ON BEHALF OF SILVER SPRING TOWNSHIP, ALL CORRESPONDENCE AND DOCUMENTS RELATED TO THE ACQUISITION AND SUBSEQUENT TRANSFER OF RIGHT-OF-WAY FOR THE SR 1011 SILVER SPRING ROAD T-585 WOODS DRIVE SIGNALIZATION PROJECT IN SILVER SPRING AND HAMPDEN TOWNSHIPS, CUMBERLAND COUNTY, PENNSYLVANIA.

WHEREAS, the Silver Spring Township Board of Supervisors is willing to acquire the rights-of-way needed under the Highway Occupancy Permit Application No. 182418 to the Pennsylvania Department of Transportation for the SR 1011 Silver Spring Road T-585 Woods Drive Signalization Project, located within Silver Spring and Hampden Townships; and

WHEREAS, the Silver Spring Township Board of Supervisors desires to authorize on behalf of the Silver Spring Township Board of Supervisors, Carl Machamer, Chair, Silver Spring Township Board of Supervisors, the ability to execute documents related to the acquisition and subsequent transfer of the needed rights-of-way for the SR 1011 Silver Spring Road T-585 Woods Drive Signalization Project; and


NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED by the Board of Supervisors of Silver Spring Township as follows:

1. Carl Machamer, Chair, Silver Spring Township Board of Supervisors is hereby authorized to execute on behalf of the Silver Spring Township Board of Supervisors, all documents related to and required for the acquisition of the rights-of-way for the SR 1011 Silver Spring Road T-585 Woods Drive Signalization Project in Silver Spring and Hampden Townships, Cumberland County, Pennsylvania, as depicted on the approved construction drawings and the right-of-way plans for the project.
2. These authorizations are effective, and retroactive to, January 1, 2020, and will self-expire upon Pennsylvania Department of Transportation District 8-0 acceptance of all right-of-way required to be transferred to the Department and the Department's acceptance of the completed Highway Occupancy Permit work for the project.
