**RESOLUTION OF THE SILVER SPRING TOWNSHIP BOARD OF SUPERVISORS
ADOPTING AND APPROVING SILVER SPRING TOWNSHIP, CUMBERLAND COUNTY,
PENNSYLVANIA AGRICULTURAL SECURITY AREA PROPOSAL WITH ADDITIONS
AND MODIFICATIONS**
