RESOLUTION NO. 2013-14

**A RESOLUTION OF THE TOWNSHIP OF SILVER SPRING,
COUNTY OF CUMBERLAND, COMMONWEALTH OF PENNSYLVANIA,
APPROVING A REQUEST FOR AN ECONOMIC DEVELOPMENT
RESTAURANT OR EATING PLACE RETAIL DISPENSER LIQUOR LICENSE
TO BE ISSUED BY THE PENNSYLVANIA LIQUOR CONTROL BOARD**

WHEREAS, Section 461 of the Liquor Code, 47 P.S. §4-461, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the issuance of economic development restaurant and eating place retail dispenser liquor licenses regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in the Township of Silver Spring, sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, Appalachian Brewing Company of Mechanicsburg, Inc., to be located at 6462 Carlisle Pike, Mechanicsburg, Pennsylvania, has requested approval of an economic development restaurant or eating place retail dispenser liquor license;

WHEREAS, the Act requires the applicant to obtain a resolution approving the economic development restaurant or eating place retail dispenser liquor license prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a resolution by the municipality, at least one hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant's intent to apply for an economic development restaurant or eating place retail dispenser liquor license in the municipality; and

WHEREAS, a public hearing on this Resolution was held on October 23, 2013, pursuant to the requirements of Section 461 of the Liquor Code; and

WHEREAS, the Board of Supervisors finds that the issuance of the economic development restaurant or eating place retail dispenser liquor license to Appalachian Brewing Company of Mechanicsburg, Inc. will promote economic development.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED by the Board of Supervisors of the Township of Silver Spring that the request of Appalachian Brewing Company of Mechanicsburg, Inc., to be located at 6462 Carlisle Pike, Mechanicsburg, Pennsylvania, for an economic development restaurant and eating place retail dispenser liquor license to be issued by the Pennsylvania Liquor Control Board is hereby approved.
