**RESOLUTION OF THE SILVER SPRING TOWNSHIP BOARD OF SUPERVISORS
ADOPTING AND APPROVING SILVER SPRING TOWNSHIP, CUMBERLAND
COUNTY, PENNSYLVANIA AGRICULTURAL SECURITY AREA PROPOSAL WITH
ADDITIONS AND MODIFICATIONS.**

WHEREAS, a proposal has been submitted to the Silver Spring Township Board of Supervisors for the review of Silver Spring Township, Cumberland County, Pennsylvania Agricultural Security Area, in accordance with the provisions of the "Agricultural Area Security Law," Act of June 30, 1981, P.L. 128, No. 43, §2, and all revisions to the said statute through Act 14 of 2001 (the "Act"), a true and correct copy of which is attached hereto and made a part hereof (the "Proposal"); and
