**RESOLUTION OF THE SILVER SPRING TOWNSHIP BOARD OF SUPERVISORS  
ADOPTING AND APPROVING SILVER SPRING TOWNSHIP, CUMBERLAND  
COUNTY, PENNSYLVANIA AGRICULTURAL SECURITY AREA PROPOSAL WITH  
ADDITIONS AND MODIFICATIONS.**

**WHEREAS**, the Proposal includes the following owner, parcel, and acreage within Silver Spring Township, Cumberland County, Pennsylvania.


