**A RESOLUTION OF
SILVER SPRING TOWNSHIP, CUMBERLAND COUNTY**

**DESIGNATING THE CUMBERLAND COUNTY TAX BUREAU AS ITS COLLECTION
AGENT, APPOINTING AN INCOME TAX OFFICER, AND ASSIGNING THE
REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO THE BOARD OF
DIRECTORS OF SAID BUREAU**

WHEREAS, Silver Spring Township Board of Supervisors has adopted the Articles of Agreement and Bylaws of the CUMBERLAND COUNTY TAX BUREAU dated January 1, 2012, as amended, and thereby became a member of the CUMBERLAND COUNTY TAX BUREAU; and

WHEREAS, the Articles of Agreement of said Bureau require that each member of said Bureau designate a representative and alternate representative to the Board of Directors of said Bureau; and

WHEREAS, the Articles of Agreement require each member to designate said Bureau as the agency to collect its Earned Income Tax and Local Services Tax/ Emergency and Municipal Services Tax (if applicable); and

WHEREAS, it is necessary for each member to appoint the Executive Director of said Bureau as its income tax officer, and

WHEREAS, said Bureau requires this to be done by resolution each year.

NOW, THEREFORE, it is hereby **RESOLVED** by the Board of Supervisors of Silver Spring Township of Cumberland County, Pennsylvania, as follows:

1. That the **CUMBERLAND COUNTY TAX BUREAU** be its agency to collect its taxes on salaries, wages, commissions, net profits and other earned income and its Local Services Tax/Emergency and Municipal Services Tax (if applicable) for the calendar year 2016. This applies to the collection and distribution of the year 2016 taxes and years prior to 2016.
2. That the Executive Director of the **CUMBERLAND COUNTY TAX BUREAU** be its income tax officer for 2016.
3. That Theresa Eberly and Cheryl Neidig be its representative and alternate representative, respectively, to the Board of Directors of the **CUMBERLAND COUNTY TAX BUREAU** for 2016.
